# PAYMENT OF CUSTOMS PAYMENTS AND PROVIDING OF PERSONAL DATA

Arrived express cargo, regardless of value, is subject to the required procedure of customs clearance.

To carry out customs clearance of express cargo, it is necessary to provide additional documents and information to the customs authorities of the Russian Federation.

The duty-free import limit until October 1, 2023 is an amount not exceeding 1000 Euros and / or a weight not exceeding 31 kilograms.
